**PRIORITY CONSIDERATIONS**

**Income:** Based on the poverty guidelines of the Administration for Children and Families. (We realize that these guidelines are low; however, this is a federal funding requirement.)

**Age:** Must be 3-years-old before August 1 and not be school-age (5-years-old before August 1). *Older children have higher priority.*

**Once income and age guidelines are met, selection is based on those with the highest priorities:**

**Disability:** *Children enrolled in the public school’s early childhood special education program receive higher priority.* Head Start must serve 10% children with disabilities.

**Exception:** Over-income children who are enrolled in the public school’s early childhood special education program will be considered if Head Start would be the best placement.

**Parents working, in school or on disability:** *Both parents are working, in school or on disability or a combination of these, or a single parent who meets one of these criteria receive higher priority.*

**The following special family circumstances also are given higher priority:** homelessness, living in a shelter, abuse or neglect, incarceration of a parent; recent death or terminal illness of immediate family member, disability or mental illness of immediate family member; suspected disability of the applicant child; and/or children living in a home other than the child’s parents (e.g. relative or foster care) who has legal custody of the child.

**Note:** *Parents can explain the above special circumstances. A professional such as a doctor or Parents As Teachers needs to write a referral letter explaining other special circumstances or problems of the child or family.*

## Parents need to have the \*following:

1. Child's birth certificate or hospital record
2. Proof of income:
  - ◆ Last year's income tax return
  - ◆ Child support printout
  - ◆ Current SSI printout from Social Security office on family member(s)
  - ◆ Social Security Survivors' Benefits/ Disability 1099 form or printout from Social Security office for all members of the family (if no income tax return)
  - ◆ Current TANF printout from Family Support Division
  - ◆ If you do not have the above, a letter from all employers within the past twelve months, stating gross wages and beginning and ending dates of employment.
3. Parent, attorney of fact, guardian's signature and social security number

*Before your child can be enrolled we will need your child's:*

1. Immunization records: these need to be up-to-date before your child is enrolled
2. Custody papers, if applicable



\*If you do not have all of these, your contact person will help you.

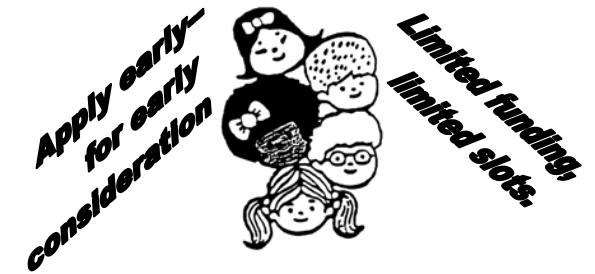
